Knowledge Quick Bites

<u>Gist of Insolvency and Bankruptcy Board of India (Fast Track Insolvency Resolution Process for Corporate Persons) Regulations, 2017</u>

- 1. The Adjudicating Authority shall appoint Interim Resolution Professional within 14 days from the insolvency commencement date.
- 2. An insolvency professional shall make a public announcement within three days from the date of his appointment calling for submission of claims by the creditors. Public announcement shall be in a prescribed format in Form A and shall be published one in English newspaper and one in a regional language newspaper having wide circulation in the place where the registered office of the company in situated.
- 3. Claims shall be submitted by operational creditors, financial creditors, workmen and employees within 10 days from the date of appointment of interim resolution professional in the prescribed format along with proof of his claim.
- 4. The interim resolution professional shall verify every claim as on the fast track commencement date, within seven days from the last date of the receipt of the claims, and thereupon maintain a list of creditors containing names of creditors along with the amount claimed by them, the amount of their claims admitted and the security interest, if any, in respect of such claims, and update it.
- 5. The interim resolution professional shall constitute a committee of creditors after collating all the claims of Debtor and on determining its Financial Position. Where the debtor company has no financial creditors, then the IBBI shall specify the constitution, composition and powers of committee of creditors.
- 6. Interim resolution professional shall file a report to Adjudicating Authority certifying the constitution of committee on or before 21 days from the date of his appointment. Based on the records of the corporate debtor and the claims, if he is of the opinion that the fast track process is not applicable to corporate debtor, he shall file an application to Adjudicating Authority to pass an order converting the fast track process to corporate insolvency resolution process under Chapter II of part II of the Code.
- 7. If the Adjudicating Authority passes an order converting fast track to corporate insolvency resolution process, the process shall be carried on in accordance with the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016. The interim resolution professional shall convene the first meeting of the committee within seven days of filing the report(s) under this Regulation.
- 8. A Resolution Professional may convene meeting of the committee as and when he considers necessary. He shall act as the chairperson of the meeting of the committee. Quorum of committee meeting shall be members of the committee representing at least 33% of voting rights who are present in person or by video conferencing or other audio and visual means. However, the committee may modify the percentage of voting rights required for quorum in respect of any future meetings of the Committee.

- 9. All the decisions of committee of creditors shall be taken by vote of not less than 75% of voting share of financial creditors. Related Party should be excluded in determining the 75% of voting share.
- 10. The interim resolution professional shall within 7 days of his appointment, appoint one registered valuer to determine the liquidation value of the corporate debtor.
- 11. In the event a creditor assigns or transfers the debt due to such creditor to any other person during the fast track process period, both parties shall provide the interim resolution professional or the resolution professional, as the case may be, the terms of such assignment or transfer and the identity of the assignee or transferee and the resolution professional shall notify each creditor and the Adjudicating Authority of any resultant change in the committee within two days of such change.
- 12. The resolution professional may sell unencumbered asset(s) of the corporate debtor, other than in the ordinary course of business, if he is of the opinion that such a sale is necessary for a better realization of value under the facts and circumstances of the case, however the book value of all assets sold during fast track process period in aggregate shall not exceed ten percent of the total claims admitted by the interim resolution professional.
- 13. The registered valuer shall submit to the interim resolution professional or the resolution professional, as the case may be, an estimate of the liquidation value computed in accordance with internationally accepted valuation standards, after physical verification of the inventory and fixed assets of the corporate debtor.
- 14. The interim resolution professional shall prepare an information memorandum in such form and manner containing such relevant information as may be specified by the Board for formulating a resolution plan. He shall submit an information memorandum in electronic form to each member of the committee.
- 15. A resolution applicant shall endeavour to submit a resolution plan prepared in accordance with the Code and these Regulations to the resolution professional, thirty days before expiry of the maximum period permitted under section 56 of Insolvency & Bankruptcy Code, 2016 for the completion of the fast track process.
- 16. The resolution professional shall submit the resolution plan approved by the committee to the Adjudicating Authority.
- 17. If the committee of creditors is of the opinion that the fast track process cannot be completed within the stipulated 90 days, it may instruct the resolution professional to make an application to the Adjudicating Authority under section 56 of the Code to extend the fast track process period. The resolution professional shall, on receiving an instruction from the committee under this Regulation, make an application to the Adjudicating Authority for such extension.
- 18. On receipt of an application, if the Adjudicating Authority is satisfied that the subject matter of the case is such that fast track corporate insolvency resolution process cannot be completed within a period of ninety days, it may, by order, extend the duration of such process beyond the said period of ninety days by such further period, as it thinks fit, but not exceeding forty-five days. Any extension of the fast track corporate insolvency resolution process under the Code shall not be granted more than once.

An Overview of Recent Important Cases

Case Highlights: M/s. Schweitzer Systemtek India Private Limited vs. M/s Phoenix ARC Private Limited

Case Title: M/s. Schweitzer Systemtek India Private Limited. vs. M/s. Phoenix ARC Private

Limited

(Initiation of corporate insolvency resolution process by corporate debtor)

NCLT Bench: Mumbai

Relevant Section: Section 10

Petitioner: M/s. Schweitzer Systemtek India Private Ltd (Corporate Debtor)

Case Facts:

Corporate Debtor raised the total debt from two Banks namely Dhanlaxmi Bank and Standard Chartered Bank respectively of Rs. 4,54, 61,524/- and 14,48,504/-. Thereafter, Dhanlaxmi Bank had assigned and transferred the debt to M/s. Phoenix ARC Pvt. Ltd. by virtue of an assignment agreement between both the parties.

The loan was secured by mortgage of personal property in favor of Dhanlaxmi Bank Limited and on modification of charge those property stood mortgaged with the Assignee (M/s. Phoenix ARC Pvt. Ltd.) Application was filed by Corporate Debtor to initiate Corporate Insolvency Resolution Process against itself.

The respondent opposed the application filed by the Corporate Debtor u/s 10 of the Code stating that it was an attempt to thwart the action taken so far for recovery of the outstanding debt. According to the respondent, although the default of non-payment had already begun, yet it appeared that the applicant has moved the forum with malafide intention.

Observation of the Bench:

- 1. The balance Sheet of the Corporate Debtor does not contain impugned heads of liability and therefore it was not clear under which head of liabilities the impugned liability would reflect. Hence it was appropriate to appoint a professional to streamline the position of the debt, which could be done only after due examination of the Books of Accounts of the Debtor. This was the first reason due to which the Bench was of the opinion that the application u/s of Insolvency & Bankruptcy Code, 2016 deserved to be admitted.
- 2. The second reason for admission was that on examination of Balance Sheet it was noticed that there were sundry creditors amounting to Rs. 3,37,74,086/- The fate of these sundry creditors was not known. There was no evidence on record to indicate that how the interest of the sundry creditors has been safeguarded. This aspect could be examined by the professional appointed on admission of the application.
- 3. The third reason to allow admission of the application was that on examination of the Balance Sheet, a huge contrast was apparent. On left side of the Balance Sheet, the liability was stated to be approximately Rs. 5,30,00,000/- but on the right hand side the fixed assets, FDRs, Bank Guarantees were significantly insufficient. The Insolvency Professional thus could iron out all the creases. The details of reserves and surplus needed due examination. The possibility of recovery from sundry debtors was also to be explored.
- 4. The fourth reason for admission of the application was that although, a loss was reflected in the profit and loss account but it was also important to examine the correctness of the loss so claimed. The professional, if allowed to proceed shall look into the profitability of the company so that if possible the company could come out of the clutches of Insolvency so that the interest of the stakeholders could also be protected.
- 5. The question before the Bench was that if the case was admitted and moratorium was declared would it be applicable to the personal properties of the promoters that was given as securities to the Banks or in other words whether the properties not owned by corporate debtor come with the ambit of Moratorium? As per section 14 of the Code, Moratorium shall be declared for prohibiting any action to recover or enforce any security interest created by corporate debtor in respect of its property. As a result "its" denote property owned by the corporate debtor. The property not owned by corporate debtor do not fall within the ambits of the moratorium.

NCLT Ruling:

The case was therefore admitted on account of reason mentioned above.

Case Highlight: D. Ramjee/N.Krishnan/C. Ganapathy vs. Aruna Hotels Limited

Case Title: D. Ramjee/N. Krishnan/C. Ganapathy vs. Aruna Hotels Limited

(Initiation of corporate insolvency resolution process by operational creditor in three different

matters against the same corporate debtor)

NCLT Bench: Chennai Relevant Section: Section 9

Petitioner: D. Ramjee/N. Krishnan/C. Ganapathy (Operational Creditor)

Respondent: Aruna Hotels Limited (Corporate Debtor)

Case Facts:

- Three separate applications were filed u/s 9 of Insolvency & Bankruptcy Code, 2016 against the same corporate debtor i.e. M/s. Aruna Hotels Limited, hence the matters were taken up to pass a common order.
- Mr. D. Ramjee, operational creditor claimed that his arrears of salary (Rs. 2,13,65,565/-), gratuity and leave salary (Rs. 47,03,318/-) totaling Rs. 2,60,68,883/- was the outstanding debt and the corporate debtor defaulted in making the payment of the same. A Demand notice for the same was sent by the petitioner on 24.03.17 to which the reply of the respondent was vague and immaterial denial of the petitioner's employment.
- A communication dated 4th April, 2014 was placed on the record containing a letter addressed to the petitioner by the Chairman & Managing Director of the company acknowledging the obligation to pay the entire arrears of salary as agreed by the company as per their earlier letters and promised to settle the amount within the period of three months from that date along with 19% interest for delaying the payment.
- The respondent denied the liabilities in his counter reply. The petitioner also filed form 20B which was filed with the ROC showing his appointment as a Company Secretary on 10.01.1985. He claimed that he was employed as Junior Assistant and then he rose to the level of Company Secretary. A copy of Board Resolution was also placed on record wherein the Board of Directors accepted the request of the petitioner to retire from the

- services of the company and the Board also appreciated the long and dedicated services rendered by the petitioner during his long association with the company for 49 years and particularly as Company Secretary for nearly 28 years.
- The issues raised by the respondent were that the matter was disputed and was barred by limitation.

Observation of the Tribunal

- As per Limitation Act, 1963, the period of limitation for any kind of wages is 3 years. Since the liability of clearing arrears of salary was acknowledged by the Managing Director vide his letter dated 04.04.2014, therefore, the limitation, if any would commence from the date of acknowledgment and the petition was filed on 03.04.2017 which was within the period of limitation.
- 2. No "Dispute" was raised by the corporate debtor in the reply to the statutory notice given by the applicant except simple denial of the liability as claimed by the petitioner.

NCLT Ruling:

The matter was admitted and order for commencement of CIRP was passed.

Rejected Cases

Case Highlight: Mr. Penugonda Satish Babu vs. Amarpali Biotech India Pvt. Ltd.

Case Title: Mr. Penugonda Satish Babu vs. Amarpali Biotech India Pvt. Ltd. (Initiation of Corporate Insolvency Resolution Process by Operational Creditor)

NCLT Bench: New Delhi Relevant Section: Section 9

Petitioner: Mr. Penugonda Satish Babu (Operational Creditor) **Respondent:** Amarpali Biotech India Pvt. Ltd. (Corporate Debtor)

Case Facts:

- The operational creditor claims that he was appointed as Clearing and Forwarding (C & F) Agent to deal with the distribution and supply of the products of the Corporate Debtor in the State of Andhra Pradesh by virtue of an Agency Agreement dated 1st May, 2014 executed between the operational creditor and corporate debtor and subsequently as per agreement a sum of Rs. 5 lacs was also deposited with the corporate debtor by way of refundable security deposit and the operational debtor was authorized by corporate debtor to obtain VAT & CST registration in relation to transfer of goods to the depot address.
- It was claimed by the operational creditor that the business of corporate debtor was stopped in the state of Andra Pradesh from 01.11.2015 and subsequent to the same no interest has been paid on security deposit of Rs. 5 lacs.
- Though, the operational creditor has approached the corporate debtor for final settlement of the claims but there was no positive response from the corporate debtor.
- As on 13.02.17, the total outstanding debt was Rs. 17,39,623/- which was also confirmed by the
 corporate debtor. A demand notice dated 13.02.17 u/s 8 of Insolvency & Bankruptcy Code, 2016
 was served and despite service of the said notice via email, the corporate debtor has neither
 responded nor paid the amounts due as claimed by the operational creditor therefore the
 application was filed by the corporate debtor for initiating CIRP under the Code.
- The respondent company was given an opportunity to file its reply. From the perusal of the reply, it was contended by the corporate debtor that the applicant had violated several clauses of the C & F Agreement and has also failed to send "Form F" duly signed and filed in relation to stock transfers to him as per CST Act. The operational creditor has also dealt in cash though it was expressly provided in the agreement that there shall be no cash transactions. The operational debtor failed to obtain the sales tax registration cancellation certificate and release the FD of Rs. 1 lac lying with the sales tax dept. in addition to the procurement of Form F from the sales tax department as well as NOC from sales tax office. It was also contended by the corporate debtor that operational creditor failed to recover a sum of Rs. 1,46,527/- from various parties to whom goods were sold.

Observation of the Tribunal:

- 1) It was quite evident that the dispute centres arising out of the appointment of operational creditor as C & F Agent and subsequent transactions emanating out of it.
- 2) There were certain duties that have not been performed to its satisfaction by the corporate debtor.
- 3) There was a bonafide dispute in relation to the accounts between the operational creditor and the corporate debtor and under such circumstances the parties should be relegated to seek remedy elsewhere, particularly, in view of the arbitration clause contained in the C & F Agreement entered into between the parties

4) The certificate issued by the bankers was not in consonance with the way it was required to be produced as it did not refer to the unpaid operational debt by the corporate debtor and about its non-payment. Also, the certificate was in relation to the period between 13th March, 2017 to 17th March, 2017 and not in relation to the duration of the agreement period prior to termination.

NCLT Ruling:

Taking into consideration the dispute as raised between the parties, it was not possible for the Tribunal in exercise of summary jurisdiction to go into the ascertainment of performance and non performance of mutual obligation as contracted between the parties. Hence the petition was rejected.

3.	M/s. Kanpur Plastipack Ltd. vs. M/s. H.L. Tech Fabrics Ltd.	The matter was filed under section 9 of The Insolvency & Bankruptcy Code, 2016 before the Principal Bench of National Company Law Tribunal. This matter was dismissed on the ground that despite the second call and opportunity being given, the petitioner did not appear.
4.	M/s. Tata Capital Financial Services Ltd. vs. M/s. Amarpali Infrastructure Pvt. Ltd.	The matter was filed under section 7 of The Insolvency & Bankruptcy Code, 2016 before the Principal Bench of National Company Law Tribunal. This matter was dismissed for non-prosecution as the petitioner did not appear.

(i) IBBI invites comments from public on the regulations already notified under the Insolvency and Bankruptcy Code- 2016

The Insolvency and Bankruptcy Board of India, vide its Press Release dated July 4, 2017, has invited comments from public, including the various stakeholders on the Regulations already notified under the Insolvency and Bankruptcy Code- 2016.

The Regulations on which the comments are invited are as follows:

- (vi) Insolvency and Bankruptcy Board of India (Information Utilities) Regulations, 2017;
- (vii) Insolvency and Bankruptcy Board of India (Voluntary Liquidation Process) Regulations, 2017;
- (viii) Insolvency and Bankruptcy Board of India (Fast Track Corporate Insolvency Resolution Process)
 Regulations, 2017; or
- (ix) Insolvency and Bankruptcy Board of India (Inspections and Investigations) Regulations, 2017.
