In Lieu of the current situation of COVID-19, and as per the IBBI Circular dated 10th July, 2020, which states that the mandatory 50 Hour training of Preregistration Educational Course will be to continue online delivery of education beyond 30th September, 2020, in addition to classroom mode, wherever possible.
