Educational Course from an Insolvency Professional Agency after his/her enrolment as a

Professional Member.

The Pre-Registration Educational Course will be conducted by expert faculties who would

share their varied advice and experience. The Course will enhance the knowledge base; sharpen the management skills with efficiency in advocacy, code of conduct and handling

insolvency effectively.
