

## **9th batch of Pre-Registration Educational Course**

**25<sup>th</sup> November, 2018 to 1<sup>st</sup> December, 2018**

### **Purpose**

The Insolvency and Bankruptcy Board of India ("IBBI") has introduced a Pre-Registration Educational Course under Regulation 5(b) of the IBBI (Insolvency Professionals) Regulations, 2016.

With effect from 1<sup>st</sup> April 2018, individuals are eligible to register themselves as Insolvency Professionals (IP) only after undergoing through the **mandatory 50 hours** Pre-Registration Educational Course from an Insolvency Professional Agency after his enrolment as a Member.

The Pre-Registration Educational Course will be conducted by expert faculties who would share their varied advice and experience. The Course will enhance the knowledge base; sharpen the management skills with efficiency in advocacy, code of conduct and handling insolvency effectively.

### **Date, Venue and Fees for the Course**

All the three IPAs viz. IIIPI, ICSI IIP and IPA ICAI, are jointly conducting the Course as detailed below:
