### **Purpose**

The Insolvency and Bankruptcy Board of India (IBBI) has introduced the Pre-Registration Educational Course under Regulation 5(b) of the IBBI (Insolvency Professionals) Regulations, 2016.

With effect from 1<sup>st</sup> April 2018, eligible Professional Member after his/her enrolment with an IPA can register themselves as Insolvency Professionals (IP) with Insolvency and Bankruptcy Board of India (IBBI), only after undergoing the **mandatory 50 hours** Pre-Registration Educational Course conducted by an Insolvency Professional Agency.

The Pre-Registration Educational Course shall be conducted by our expert faculties who would share their knowledge, enriching experiences, practical aspects, and guidance to function as an effective and efficient IP. The Course will enhance the knowledge base; sharpen the management skills with efficiency in advocacy, code of conduct and handling insolvency effectively.

***Since the unfortunate advent of COVID-19, the guidelines and directions of IBBI is to conduct the subject course (50 Hour training of Pre-registration Educational Course) ONLINE till 30 September 2022. Accordingly, the said course shall be conducted online from 22nd August (Monday) to 28th August 2022(Sunday).***
