Purpose

The Insolvency and Bankruptcy Board of India (IBBI) has introduced the Pre-Registration Educational Course under Regulation 5(b) of the IBBI (Insolvency Professionals) Regulations, 2016.

With effect from 1st April 2018, individuals are eligible to register themselves as Insolvency Professionals (IP) only after undergoing through the **mandatory 50 hours** Pre-Registration Educational Course from an Insolvency Professional Agency after his/her enrolment as a Professional Member.

The Pre-Registration Educational Course will be conducted by expert faculties who would share their varied advice and experiences. The Course will enhance the knowledge base; sharpen the management skills with efficiency in advocacy, code of conduct and handling insolvency effectively.

In Lieu of the current situation of COVID-19, and as per the existing guidelines and directions of IBBI, mandatory 50 Hour training of Pre-registration Educational Course will continue online delivery till 30 June 2022.
