➤ Maharashtra State to amend stamp duty law for NCLT orders

Mumbai: The state cabinet on Wednesday approved a proposal to amend the Maharashtra Stamp Act to enable the recovery of stamp duty on orders passed by the National Company Law Tribunal (NCLT) or under the Bankruptcy Act for industrial and financial reconstruction of companies as it involved merger, demerger or amalgamation of companies. At present, stamp duty is chargeable on these activities under the Companies Act 2013 or Banking Regulation Act 1949.
