## Updates on Insolvency and Bankruptcy Code

#### > IBC may come up in Budget session for faster resolution, cross-border norms

The proposed legislative changes also include a code of conduct for the committee of creditors (CoC) that decides on insolvency resolution proposals. The Insolvency and Bankruptcy Code (IBC) could soon see some strengthening, including a cross-border insolvency framework and measures to speed up resolution of cases, with the matter set to be taken up in the upcoming budget session of parliament, government insiders said.

"Although the court has directed to restart the process, lenders can go ahead with it only after a resolution on this is passed by the requisite majority," said one of the lenders. ## Since SC Extended Limitation, No Need To File Application For Condonation Of Delay; NCLAT Delhi

Frontline (NCR) Business Solutions Pvt. Ltd., has held that in order to seek the benefit of the judgment of the Hon'ble Supreme Court passed in Suo Motu Writ Petition No. 3 of 2020, extending the period of limitation due to COVID 19, an Applicant is not required to file an application under Section 5 of the Limitation Act, 1963 and satisfy the Court/ Tribunal that sufficient cause has been made out for condonation of delay.

## > <u>A code for the committee of creditors</u>

The Insolvency and Bankruptcy Board of India (IBBI) issued a discussion paper in August 2021 proposing a code of conduct (code) for the committee of creditors (CoC) to ensure transparency in its functioning. This followed the observation of the Parliamentary Standing Committee of Finance in its 32nd Report in early August, "...there is an urgent need to have a professional code of conduct for the committee of creditors which will define and circumscribe their decisions".
