<u>cracking down on cartels: Penalties must be based on turnover so punishments are proportiona:</u> The Supreme Court observed that market conditions may be such as to have driven the suppliers to form a cartel. While the practices of a procuring company may be such as to weaken competition between suppliers, this cannot be a justification for suppliers to upfront collude in the submission of bids instead of competing in bids. It is incumbent on the appellate tribunal (NCLAT) and the courts to have a better appreciation of the deeply damaging effects of cartels and decide these cases with a sense of urgency.

Sackler Immunity and a Texas Two-Step Could Tilt Bankruptcy Scales

Away From Victims: The billionaire owners of OxyContin maker Purdue Pharma LP and lumber giant Georgia-Pacific are in high-stakes legal battles to shed billions of dollars of liabilities in bankruptcy -- the first over their company's alleged role in America's opioid crisis and the second for 64,000 asbestos claims. If they are successful, it threatens to reduce the bargaining power of alleged victims of corporate abuse for years to come. In New York, U.S. Bankruptcy Judge Robert Drain could rule as early as Thursday on whether to grant the Sackler family broad immunity to all current and future lawsuits related to the addictive painkiller.
